Part B. CV SUMMARY

Current position and awards. I have dedicated the past decade to the study of Cuban and Mexican women's history in the first half of the 20th century. Currently, I hold the position of Tenure Scientist at the Institute of History, Spanish National Research Council. I have received accreditation as a Contracted Doctor from ANECA (2021), and I was a candidate for the National Researchers System of CONACYT, Mexico (2019-22). Notably, I was honored with the IX Thesis Prize in Women's Studies from the Spanish Association for the Research on Women's History (2018) and the University of Castilla-La Mancha Thesis Prize in Humanities (2019).

Scientific contributions. My research has addressed a historiographical gap concerning Latin American women in the twentieth century by studying two main topics: popular Afro-Cuban and Mexican rural women's associations (1930-1950), and the role of women in the Cuban insurrection (1952-59). The resulting publications contributed to make innovative questions, hypothesis, and ideas within the history of Latin American women. The first research line has applied a bottom-up and intersectional methodological approach to analyze archival documentation through the lens of intersectionality, i.e., by taking into account how racial, class, and gender discrimination intersected for the bad (the oppressive postcolonial structures), and for the good (the social groups that mobilized against them). The second research line enriched clandestine documentation by analyzing oral testimonies of women that took part in the fight against the dictatorship of Fulgencio Batista, a valid source of information full of meanings and life experiences that cannot be found in written documents. The research problems, methods, and results have been shared in numerous communication and dissemination activities as it is detailed in the "Contributions to society" section.

Funding and new research skills. These research contributions were made possible through participation in the work team within three national projects, an international network of excellence, and an international project (see C.3.). Besides, I was awarded public scholarships or funding to conduct research stays: University of Havana (2014, 16), Harvard University's Hutchins Center for African and African-American Research (2015), University of Miami's Cuban Heritage Collection (2015), and Université de Versailles (2016). Likewise, I obtained a Postdoctoral Fellowship in Humanities at the Institute of Historical Research, National Autonomous University of Mexico, UNAM (2018-20). The collaboration and participation with the host research groups allowed me to get skills and learn new methods of research that I then applied in conferences, lectures, and publications.

International collaboration and leadership. I have engaged in two notable international collaborations: 1) to study the life of Esperanza Sánchez Mastrapa, the first black Cuban woman parliamentarian (*Women's History Review*, 2022), and 2) to publish a special issue on Latin American in *Historia Caribe*.

Contributions to society. I have participated in outreach activities: *Science Week* in Spain (2014), the *Science and Humanities Festival* at the UNAM (2020), and the *History Week* at the Autonomous Metropolitan University (2019); guided tours as part of the *Science Week* arranged by CSIC (2013, 2014, 2025); written an article for the magazine *Rialta* (2021), and for the Institute of Latin American Studies's blog, Univ. of London (2018); given lectures at the Ibero-American University (2020), and a workshop at the VIII Coloquio Internacional 'Historia de Género y de las Mujeres en México' (2020, Autonomous University of Sonora). I would also highlight the organization of a series of 20 dissemination online lectures (Sept-Dec, 2020) at the Museo de la Mujer (Mexico) (inaugural: <https://www.facebook.com/MuseodelaMujerMexico/videos/2825160917807519/>).

Training capacity. Since 2021, I have supervised 4 thesis for the Master's in Latin America and Europe (University Research Institute for Latin American Studies, University of Alcalá), and 54 thesis for the Master's in Teacher Training for Secondary Education (International University of La Rioja), with an average rating of 7.7/10.

Scientific responsibilities. Currently, I hold the position of Scientific Editor at the *Culture & History Digital Journal*, a Scopus and WoS journal hosted at CSIC, as well as a member of the Scientific Board of the Doce Calles Editorial's *Antillia collection*. I have conducted article peer reviews for international indexed journals, such as *Latin American Research Review* (2023), or *Journal of Black Studies* (2023).

Other scientific activities. Additionally, I co-organized the International Congress, "La Esclavitud y sus huellas". Casa de América, Madrid. (nov. 2017), and the International ConnecCaribbean Seminar "Historia Social y cultural en el Gran Caribe, siglos XIX-XX", Institute of History CSIC (may to june 2022).
